

STZ NETWORK PRIVACY POLICY

This document discloses the privacy practices for STZ Network, a website (the “Site” or “Website”) owned and operated by STZ Network, LLC ("Privacy Policy"). As part of the normal operation of STZ Network’s services, we collect and, in some cases, disclose information about you to third parties. This Privacy Policy describes the information we collect about you, how STZ Network may use such information, and what may happen to that information. By accepting the Terms of Service Statement (located at: stznetwork.com/tos), you expressly consent to our use and disclosure of your personally identifiable information in accordance with this Privacy Policy and applicable law. This Privacy Policy is incorporated into and subject to the terms of the STZ Network’s Terms of Service Statement.

1. Minors. If you are a minor (under the age of 18), you can use this service only [in conjunction with / with the consent and under the supervision of] your parents or legal guardians. If you are a minor, please do not submit any personal information to this website. If you believe that a user under the age of 13 may have provided us personal information in violation of this Privacy Policy, please contact us at legal@stznetwork.com. **IF YOU ARE 13 YEARS OR YOUNGER, PLEASE DO NOT USE STZ NETWORK OR ANY OF ITS SERVICES FOR ANY PURPOSE AT ANY TIME.**

2. Information We Collect.

(a) Your Registration Information. To fully use our services, you will need to register using our online registration form, where you will be required to provide us with your contact information and certain other personal information, namely, email address, phone number, date of birth, first and last name, and site preferences.

(b) Your Usage of Our Site. Like most websites, we automatically track certain information about you based upon your use of our Site and to collect certain basic information about you and your browsing habits. We use this information to conduct internal research on our users' demographics, interests, and behavior to better understand and serve our users. This information is compiled and analyzed on an aggregate non-anonymized basis. This information may include the URL that you just came from, which URL you next go to, your operating system, keywords, date and time, time spent on particular pages, what browser you are using, and your IP address(es), among other things.

(c) Cookies. In addition, we use "cookies" on certain pages of our Site. Cookies are small files that can be used to track a user's steps or automatically generate a user's password. Some features of our Website may only be available through the use of a cookie. Among other things, cookies allow you to enter your password less frequently during a session. Cookies can also help us provide information which is targeted to your interests. Cookies are stored on your hard drive, not on our Site. Most, but not all, cookies are automatically deleted at the end of a session. You may decline our cookies if your browser permits, although your use of the Site may then be restricted (as noted above).

(d) Your Posts. If you choose to post information through the Site, we will collect such information about you as you may choose to disclose pursuant to your activities on the Site.

(e) **Your Correspondence.** If you send us e-mails, letters or other personal correspondence, or if other users or third parties send us correspondence about your activities or postings on the Website, we may collect such information into a file specific to you.

(f) **Your Credit Account.** If you establish a credit account with us, we collect some additional information, including billing address, credit card number, and credit card expiration date and tracking information from checks or money orders.

3. Our Use of Your Information.

(a) **Promotional Use.** We use personal information about you to enhance our marketing and promotional efforts, and to improve our content and services. We may also use your information to deliver to you advertisements, new services and promotions, and other information to you that is targeted to your interests. You can avoid receiving some of this information by changing your options on your account status page.

(b) **Administrative Notices, etc.** We use your e-mail address, your mailing address, and phone number to contact you regarding administrative notices, new product offerings, and communications relevant to your use of the Site. If you do not wish to receive these communications, you may have the ability to opt out of receiving these notices on your account status page.

(c) **Billing and Support.** If you open a credit account with our Website, we use your address and billing information to bill you and provide associated support. This information may be shared with a third party service provider as necessary to process your payments and the information would be subject to the privacy policies and practices of the third party service provider. By opening a credit account with our Website, you acknowledge and agree to the use of such information by the third party service provider for the purposes of processing your payment to us.

(d) **Dispute Resolution.** We use information in the file we maintain about you, and other information we obtain from your current and past activities on the Site, to resolve disputes, troubleshoot problems, and enforce our Terms of Service Statement.

4. Our Disclosure to Third Parties. We use practices that are consistent with standards in our industry to protect your privacy. We cannot, however, promise that your personally identifiable information or private communications will remain private. For example, third parties may unlawfully intercept or access transmissions or private communications on our Website. We do not sell or rent any personally identifiable information about you to any third party. The following describes the ways that your personally identifiable information may be disclosed.

(a) **Law Enforcement.** We may disclose any information about you to law enforcement or other government officials as we, in our sole discretion or as otherwise required by law, believe necessary or appropriate, in connection with an investigation of fraud, intellectual property infringements, or other activity that is illegal or may expose us to legal liability.

(b) **Advertisers.** We disclose aggregate information about our users to advertisers and for other marketing and promotional purposes. However, we do not disclose any personally identifying information to any of these entities.

(c) **STZ Network Site.** Throughout the Site, you are identified by your User ID. Unless you select a unique User ID, our system automatically sets your User ID as your [e-mail address]. In this situation, where you are identified on the Site by your User ID, you disclose your e-mail address to other users and third parties. As a result, other users and third parties might send you unsolicited e-mail and be able to personally identify all of your activities on the Site. Although our pages are coded with robot exclusion headers, others may attempt to automatically collect your information from our Site. We describe how to change your User ID on their profile tab within the application. Even if your User ID is not your e-mail address, your User ID can be used to identify you and your activities throughout the Site. Other people can see your activities on the Site, including any of your comments and postings on the Site, and so on.

(d) **Third Party Suppliers.** We may use third party suppliers to assist us in providing the services available on an outside website. Whenever a third party supplier desires to collect information about you, you will be notified of the involvement of the third party supplier, and you will never be required to disclose any information to the third party supplier. We impose contractual restrictions on the use by our third party suppliers of information concerning you, and we do not permit third party suppliers to sell your information to other third parties.

(e) **Use Limited to Site-Related Communications.** Because of the nature of the services offered on STZ Network, STZ Network allows you to access other users' contact information. You may use such information only for STZ Network-related communications. STZ Network-related communication expressly excludes unsolicited commercial messages. Therefore, you must not post, upload, link, or otherwise use the Site in any manner for any commercial purpose or endeavor, including the offering for sale of any products or services, or otherwise engage in any commercial activity on the Site for any purpose, including, but not limited to, conducting raffles or contests, displaying sponsorship banners, soliciting goods or services, soliciting funds, advertisers, or sponsors. In all cases, you must give users an opportunity to remove themselves from your database and a chance to review what information you have collected about them. In addition, under no circumstances can you disclose personally identifiable information about another user to any third party without our consent and the consent of such other user after adequate disclosure by you to such other user. Note that law enforcement personnel and other rights holders are given different rights with respect to information they access.

(f) **No Spam.** STZ Network and our users do not tolerate spam. Therefore, without limiting the foregoing, you are not licensed to add a STZ Network user to your mail list (e-mail or physical mail) without their express consent after adequate disclosure.

5. Disclosures You Make to Third Parties. The Site may contain content, services, advertising and other materials that link to websites operated by third parties. STZ Network does not control the privacy policies of third parties, and this Privacy Policy does not apply to them. When you disclose information to third parties on STZ Network (or any other website) about yourself, you are subject to the privacy customs and policies of that third party. It is your responsibility to find out about the privacy policy of any such third parties.

6. Changes to Privacy Policy. STZ Network reserves the right at any time to make changes, modifications, alterations and/or additions to this Privacy Policy. STZ Network will notify you of any changes to this Privacy Policy by providing you with notice of such changes at

your email address that you provided the Site as your primary contact information. By accessing the Site after we make any such changes to this Privacy Policy, you are deemed to have accepted such changes. Please refer back to this Privacy Policy on a regular basis.

7. Important Notice to Users Outside the U.S. STZ Network and its related services are operated in the United States. If you are located outside of the United States, please be aware that any information you provide to us will be transferred to the United States. By providing us with any information through the Site you consent to this transfer.

9. Effective Date of Privacy Policy. The effective date of this Privacy Policy is April 16, 2021.

10. How We Protect Your Personal Information. STZ Network uses all commercially practicable means to protect your personal information from being improperly accessed by third parties at any time, including without limitation, encryption processes in connection with credit card and other financial information. Additionally, to the extent that we do not foresee a continued use of any such information, we will promptly destroy such information without retaining copies for our files.

11. What You Can Do about Your Personal Information. At any time, you may submit a written request inquiring about what personal information we have collected about you in order to: (i) edit such information; or (ii) request its deletion. We will timely respond to any such requests and use all commercially practicable efforts to comply with your demands, unless not legally or otherwise permissible. 12. Governing Law. This Privacy Policy shall be governed by the laws of the State of South Carolina without regard to its conflict of laws principles. Users agree that the courts in Greenville County, South Carolina shall have personal jurisdiction over them in connection with any such disputes.
